My father was selected as Airforce Pilot from Birbhum District in between 1960 -1965.

A group destroying organisation and industry and education system in West Bengal, those group are assasinating Businessman, family members of Government officers, Engineers, Scientists, Doctors and family members of sports person, destroying health of sports person for more than last 50 years.

I lost 12 women family members and relatives in West Bengal.
