I am Sanchayan Ghosh and our family members including my father Mr Samiran Ghosh son of Gour Chandra Ghosh, selected as Airforce Pilot, served State Government of West Bengal and Central Government and Indian Defence Garden Reach Shipbuilders for more than 40 years, cell phone number 9547339241, 7318722598, my sister Mrs Tania Biswas 7980631980 Journalist, my nephew Mr Saswata Bairagya 9378299581 4th Year Computer Science Engineer and my Niece Miss Tanbi Biswas 9163870656 student of class 9, my brother in law Mr Biswajit Biswas 9163870656 General Manager Reliance Jio are getting physical and mental torture inside West Bengal for more than 16 years. They have assasineted my mother Mrs Gouri Ghosh and sister Mrs Jinia Bairagya (Ghosh) and second mother Mrs Padma Ghosh. They have assasineted 12 women family members and relatives.

A group openly giving life threat to our family members infront of Police for last several decades.

When I was working with Tata Consultancy Services Limited Kolkata, I was attacked on regular basis traveling to office and returning back from office, in between 2008 to 2016.

My office colleague of Tata Consultancy Services Limited-Kolkta Mr Aniruddha Bannerjee phone number - 9903038963 is witnessed that police never logged FIR against anti-social and criminals when I requested them and reported them.

A serial killer group has assasineted daughter of my cousin brother Mrs Piue Ghosh PhD in Engineering from IIT Gandhinagar. She has informed police in between 2008 to 2010 about her life threat, she was assasineted in Gandhinagar on 4th July 2020 Independence Day of America, police describing it as suicide. I have also informed Kolkata Police about her life threat through email, through phone call and personally visiting police station more than 30 times.

Husband of Mrs Piue Ghosh working at USA and he is also PhD in Engineering, she was preparing to travel USA in the month of July August 2020.

Similarly they have assasineted my sister Mrs Jinia Bairagya on 20th August 2020 and make continuous phone call at a cell phone number 9916877791 and ask me to describe what has happened in West Bengal and with our family, when I was describing they hangged my sister and describing their enjoyment of assasinating my sister, she has immigration of USA.

Similarly they have assasineted my sister in law, wife of my cousin brother Mrs Kinnori Chatterjee who is USA immigrant, his husband Mr Soumyajit Sarkar PhD in Engineering from Verginia Commonwealth University USA. She was assasineted at Kolkata.

They have assasineted Miss Jigisha Ghosh my cousin sister working as area operation manager of Hewitt Associates, his father Mr J N Ghosh was a senior government officers working for Parliament of India.

I have informed and seek help from Member of Parliament of Barrackpore Mr. Tarit Baran Topdar, former Minister of food and agriculture Mr Naren De -9432641936.

My father has visited recedence of Chief Minister Smt Mamata Bannerjee in 2014, however no support we received, rather than anti social of West Bengal increased torture on our family members and assassinated my family members and relatives.

They have never help me to transfer different location in India or different organisation, even they have not gave release letter to join me in Tata Motors Pune Engineering Research Center where I have Job offer letter as manager position in research and development center in 2008.

I am not having any salary for last 9 years.

I am continuously under attack by invisible weapon and physical attack from 2007 to 2025.

I have been isolated initiating a process who using fraud voice and fraud thought producing system.

Former Honorable President of India President Mr. Pranab Mukherjee, Congress Chairperson Shri Rahul Gandhi ji, former Chief Minister Mr Vilasrao Deshmukh and FBI directors had provided information to stop isolating me illegally using fraud information.

When I submitted design registration at patent office Kolkata for Rado watch I was also bitten badly at Kolkata.

I stayed with Honourable Former President of India Dr. A P J Abdul Kalam two day in 2003.

People associated with Police of West Bengal stolen gift given by former President Dr A P J Abdul Kalam.
